The Nominating Committee, appointed by the Chairman of the Board of Directors, has nominated one Member for each board position to be filled. The four nominees are Mr. George Thompson, Jr., Dr. Joe Bean, Dr. Rich Dear, and Mr. Randall Armstrong. A brief statement of qualifications and biographical data for each of the nominees is included with this notice.

Further nominations may be made by official petition signed by 500 eligible Members. Official petitions may be obtained by contacting the Secretary of the Board of Directors, Dr. Joe Bean, at EECU, 1617 W. 7th St., Fort Worth, Texas 76102, and must include each signer's name, address and telephone number. To be eligible for election, Members must be at least 21 years of age and have never been convicted of a criminal offense involving dishonesty or breach of trust. They must also be a Member in good standing with the credit union.

Official petitions must be accompanied by a signed statement from the nominee that he or she is agreeable to the nomination and will accept office if elected. Petitions should also include a brief statement of qualifications and biographical data.

Official petitions must be filed with the Secretary of the Board of Directors, Dr. Joe Bean, at EECU, 1617 W. 7th St., Fort Worth, Texas 76102, no later than February 15, 2024, which is the closing date for receiving nominations by petition. If no official petitions are filed by February 15, 2024 there will be no election by ballot and no nominations from the floor. When only one Member is nominated for each position to be filled, each nominee shall be deemed elected by general consent or acclamation. If there is more than one nominee for any position, the election shall be by ballot at the Annual Meeting.

George Thompson, Jr.

Mr. Thompson has been a member of EECU since 1980 and has served on the Board of Directors since 1989. He currently serves as Chairman of the Board of Directors, ALCO Committee and Trustees. He also is Vice-Chair of the Member Business Lending Committee and is a member of the Audit, Board Education and Training, and Board Member Selection Committees. He holds a Bachelor of Science degree from Wiley College, Master of Education degree from Tuskegee University, and Educational Administration Certification from Texas A&M University, Commerce. Additional study was completed at Harvard University. He retired from Fort Worth ISD after 41 years of public school service, including 17 years as Principal of William James Middle School. Other educational experience includes teaching positions with the Teague ISD, Dallas ISD, and Fort Worth ISD where he taught mathematics and science. He served as assistant principal at Forest Oak Middle School and Southwest High School in the Fort Worth ISD. He worked two years on special assignment with Fort Worth ISD in the office of Secondary Administration and the Human Resource Department. He is a member of Gambrell Street Baptist Church

where he has served as a teacher, deacon, and trustee. Mr. Thompson has served as director of the Fort Worth Parenting Center and as a Trustee of the Fort Worth Opera Association. He has been a member and participant of Leadership and Forum Fort Worth, and a member of Alpha Phi Alpha Fraternity Inc. He has served as an Explorer Scout Advisor in the Boy Scouts of America, and a Past Master in The Prince Hall Grand Lodge of Texas. Rich Dear, Ed.D.

Dr. Dear began his career at Brewer High School as a science teacher and coach before assuming the position of assistant principal. He then served as principal of Godley High School and currently serves as Godley ISD Superintendent. Dr. Dear is Chairman of the Johnson County Shared Service Arrangement (JCSSA), and a board member of Cross Timbers School Development Council. He is a founding member of the Future Ready Schools Consortium of North Texas, an associate member of the Texas Association of School Administrators (TASA) High Performance Schools Consortium, Texas Association of School Administrators (TASA) School Board of the Year selection committee. Dr. Dear is also a member of the Future-Ready Superintendents Leadership Network, ESC Region XI Strategic Planning Committee, ESC
